Summer Jam at PGA Frisco 2025 OMNI Sweepstakes (the "<u>Sweepstakes</u>") Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

This Sweepstakes is being held in connection with the 2025 PGA Buying Summit scheduled to take place at the Omni PGA Frisco Resort and Spa in Frisco, TX, from July 28 through July 30, 2025 (the "Event").

1. SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:01 AM (ET) on June 6, 2025, and ends at 8:00 PM (ET) on July 29, 2025 (the "<u>Sweepstakes Period</u>").

2. HOW TO ENTER: Each person who (i) enters the Sweepstakes and (ii) meets the eligibility requirements as described in Section 6 herein shall be referred to as a "<u>Participant</u>". During the Sweepstakes Period, eligible Participants may enter the Sweepstakes by registering for complimentary admission to the Event on the official Event website.

Limit one entry per Participant. Multiple entries from the same Participant are not permitted. Entries by the same Participant in excess of the limits stated herein will be disqualified. Entering or attempting to enter the Sweepstakes multiple times through (i) the use of any robotic or automated devices to submit entries; (ii) with the use of duplicate email accounts and/or Event registration, or (iii) the use of multiple email accounts and/or Event registrations for a single individual, are prohibited and will be deemed void and disqualified.

All entries must be received during the Sweepstakes Period. Eastern Time shall control for all purposes of this Sweepstakes. Sponsor's clock shall be the official timekeeper for the Sweepstakes. All entries become the property of Sponsor and will not be acknowledged or returned. Incomplete entries will be considered invalid and ineligible to win. In the event of a dispute over the identity of a Participant, an entry will be deemed submitted by the authorized account holder of the email address associated with the email account and/or Event registration from which the entry was submitted at the time of entry. "<u>Authorized account holder</u>" is defined as the natural person who is assigned to the account by the applicable online service provider or organization.

3. PRIZES: One (1) winner will be awarded one (1) certificate for one (1) complimentary standard hotel room for one (1) night (up to a \$500.00 value) at the OMNI PGA Frisco Resort and Spa in Frisco, TX (each, a "<u>Prize</u>" and, collectively, the "<u>Prizes</u>") (the total estimated retail value of each Prize is US\$1.00). Prize redemption is based on availability and shall only cover the basic room rates and taxes and not for any incidentals, including, but not limited to, in-room movies and phone calls, bar tabs, WiFi charges, resort fees, catering, meals or additional travel expense coverage or fees in connection with the Prize. The drawing will be conducted by Sponsor, whose decisions are final and binding on all matters relating to this Sweepstakes. Winners MUST be present to win. Odds of winning are dependent upon the total number of eligible entries received. Sponsor will attempt to notify the potential winner on-site at the Event or by email on July 30, 2025. The potential winners will have forty-eight (48) hours from receipt of such notification to claim their Prize as noted by Sponsor in the Prize notification. After claiming the Prize, each potential winner will receive instructions on redeeming their Prize. Sponsor reserves the right, in its sole discretion, to not select a winner(s) if an insufficient number of eligible, complete, appropriate or generally qualified entries are received.

If there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules will prevail, govern and control. Headings and captions are used in these Official Rules solely for convenience and ease of reference and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof.

6. All Participants must be able to provide proof of identification and eligibility if requested by Sponsor.

All Participants are expected to review the Privacy Policy carefully before participating in the Sweepstakes and each Participant acknowledges that, in the event of a conflict or inconsistency between the terms of these Official Rules and the terms of the Privacy Policy, the terms of the Privacy Policy shall prevail, govern and control. In addition, Sponsor may engage third party entities to administer certain aspects of the Sweepstakes, including without limitation, the collection of Participant information. Notwithstanding anything to the contrary in the Privacy Policy, Sponsor may share Participant's information with third party entities to the extent needed to perform their duties and functions in connection with the Sweepstakes or otherwise in accordance with their own independent privacy practices.
